### JANUARY 2021



This month in Saint history for Human Rights: 20th January 1961: Governor Robert Alford opens the new Jamestown Primary School buildings (now Pilling School).

1st January 1967: A new Constitution comes into force, with major changes to the island's governing bodies and the introduction of democracy.

20th January 2020: The UK Privy Council rejects an appeal by the Government of St Helena, forcing it to pay 100% of the compensation due to the victims in a medical mismanagement case. The Government of St Helena had argued that it should only have to pay ½.

The Equality & Human Rights Commission assisted in the defence against the appeal.

## THE WORLD CAFE ON ST HELENA

The World Cafe is a simple yet sophisticated method for holding meaningful conversations about important questions.

The World Cafe event is being lead by Samantha Dunn on the 6th February 2021. This is a study into exploring creative ways of supporting children's right to participate in research to understand their lived experiences as a part of her Doctorate in Education (EdD).

This event will explore what children and young people on St Helena believe matters to them. This is to support children's right to participate in decision making and to explore childhood through St Helenian children's perspectives. This will be done by holding an event in Jamestown for children and young people ages 10-16 years.
